BFGcon Vendor Agreement

One for All Events is the promotor and event management company for BFGcon taking place March 13-15, 2020 at the Clarion Inn & Event Center, Frederick MD ("Facility").

1. **Vendor Fees.** Vendor shall pay a fee, as indicated appropriate to the space desired for the right to use space to display its products and services at BFGcon. Vendor shall pay any sales or use tax in addition to the fees if any taxes are assessed. **The Vendor Fee is NON-REFUNDABLE after February 1st.**
2. **Space Assignment.** Vendor may indicate a preference for a specific location, but One for All Events maintains the sole and exclusive right to assign space in its discretion.
3. **Vendor Regulations.** Vendor may display its products and services according to the following regulations:
 - a. BFGcon is a family event. Vendors may not display adult-oriented products. Vendors may not display images, video, or other media containing excessive violence or material of a sexual nature. One for All Events maintains the exclusive right to prohibit the display or sale of inappropriate products.
 - b. Space may not be shared with another Vendor or an unregistered Vendor.
 - c. Vendors shall not sell or distribute food or drink.
 - d. Vendors shall not allow their signage, product displays, or personnel to block or otherwise impede access to any other Vendor.
 - e. Vendors shall not engage in aggressive sales tactics or poaching of BFGcon attendees from other Vendors.
 - f. If Vendor has any electric or electronic equipment; they shall ensure that electrical outlets are not overloaded or dangerously connected.
 - g. BFGcon does not provide security for Vendors and disclaims all liability for lost, stolen, or damaged displays, equipment, or goods.
 - h. Vendors may sell directly to BFGcon attendees, but the Vendor is solely responsible for the payment of all relevant state and local sales taxes. Vendors who wish to sell products are responsible for obtaining all necessary licenses to sell products at BFGcon. **One for All Events does not have a Trader's License for the sale of products and disclaims all liability for violations of law or regulation related to licenses to sell products.**
 - i. In accordance with Maryland Law, Vendor **shall** provide a copy of a valid **Trader's License or an Exhibitor's Affidavit** prior to the show, and must conspicuously display a copy during the event.
4. **Vendor Set-Up and Tear-Down.** Vendor shall set up all merchandise and displays no later than 30 minutes prior to the opening of BFGcon each day. Vendor shall not tear down until one hour before BFGcon ends.
5. **Violations of Vendor Regulations/Set-up/Tear-Down Policy.** Vendors who fail to adhere to the Vendor Regulations or Set-Up/Tear-Down policies may be removed from BFGcon, closed, fined up to \$250, or any combination of these sanctions. One for All Events may assess sanctions with or without notice to Vendor.
6. **Facility Policies.** BFGcon, One for All Events, and Vendor are guests of the Facility. Vendor shall abide by all Facility safety and use policies. If the Facility notes violations of its policies to One for All Events, then One for All Events may assess sanctions described in Paragraph 5.
7. **Disclaimers and Liability Limits. *While One for All Events will attempt to maximize attendance at BFGcon, One for All Events does not guarantee the number, nature, or quality of attendees. One for All Events disclaims all liability, including monetary losses, lost profits, or any other business loss suffered by Vendor related to participating in BFGcon. One for All Events disclaims all liability suffered by Vendor resulting from any actions or negligence of the Facility, other vendors, attendees or the Vendor's actions or negligence. In any case except fraud, willful destruction of Vendor's property, or gross negligence resulting in injury to Vendor personnel, One for All Events' liability is limited only to the Vendor Fee paid for BFGcon.***
8. **Indemnification.** Vendor shall indemnify One for All Events against any claim brought by or loss suffered by any third party, including the Facility, other vendors, attendees, government agencies, or any other third party resulting from Vendor's actions, negligence of any sort, and violations of this agreement.
9. **Dispute Resolution.** The laws of the State of Maryland apply to the enforcement and interpretation of this agreement. The parties shall bring any claim related to this agreement in the Maryland state courts in Frederick County, Maryland.

By signing this agreement/application, Vendor agrees to abide by the terms of this contract and any policies issued by BFGcon.
